

## **MYFMBUTLER\* EID 4.0 SOFTWARE LICENSE AGREEMENT**

This is a legal agreement between you and myFMbutler covering your use of myFMbutler EID 4.0, hereafter referred to as 'the Software'. Be sure to read the following agreement before using the software.
